A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO SPEEDWAY FUEL SUPPLY CORPORATION (CALTEX GASOLINE STATION) FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING STATION LOCATED AT NO. 693 REPUBLIC AVENUE, SAUYO ROAD, BARANGAY SAUYO, NOVALICHES, DISTRICT VI, QUEZON CITY.

WHEREAS, Speedway Fuel Supply Corporation, a business entity duly registered under Philippine laws, is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a Gasoline Refilling Station located at No. 693 Republic Avenue, Sauyo Road, Barangay Sauyo, Novaliches, District VI, Quezon City;

WHEREAS, the Sangguniang Barangay of Sauyo, and the residents therein interposes no objection to the proposed construction because of the benefits and development that will be realized due to the said project;

WHEREAS, under Section 53 of Ordinance No. SP-2502, S-2016 otherwise known as the Comprehensive Zoning Ordinance of 2016, a Special Use Permit (SUP) shall be required for the construction and operation of a gasoline refilling station, subject to the authorization of the City Council through a Resolution;

WHEREAS, the proposed gasoline refilling station has complied with all the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned zoning ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to Speedway Fuel Supply Corporation (Caltex Gasoline Station) for the construction and operation of a gasoline refilling station located at No. 693 Republic Avenue, Sauyo Road, Barangay Sauyo, Novaliches, District VI, Quezon City.
