A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO EXECUTE THE CONTRACTS TO SELL/AGREEMENT, DEED OF ABSOLUTE SALE WITH THE QUALIFIED BENEFICIARIES OF THE CITY'S SOCIALIZED HOUSING PROGRAMS UNDER THE DIRECT SALE PROGRAM, PUBLIC RENTAL HOUSING PROGRAM, AND TRANSITION HOUSING PROGRAM, AND TO SIGN DOCUMENTS PERTAINING TO THE COMMUNITY MORTGAGE PROGRAM (CMP), HIGH DENSITY HOUSING (HDH), AND VERTICAL HOUSING PROGRAM OF THE SOCIAL HOUSING FINANCE CORPORATION (SHFC) FOR AND IN BEHALF OF THE LOCAL GOVERNMENT OF QUEZON CITY.

WHEREAS, Republic Act No. 7279, otherwise known as the Urban Development and Housing Act of 1992, mandates the State, through the local government units, to develop and implement a comprehensive urban development and housing program;

WHEREAS, in the fulfillment of this mandate, the Quezon City Government had developed and implemented policies to provide affordable and adequate housing to all residents, especially Informal Settler Families (ISFs) living in danger areas;

WHEREAS, there is a need to introduce policies and programmatic interventions in order to achieve the City's goal of providing affordable and adequate housing for all of its residents;

WHEREAS, it is necessary to enter into Contracts to Sell/Agreement, Deed of Absolute Sale and to sign other necessary documents pertaining to the City's Socialized Housing Programs under the Direct Sale Program, Public Rental Housing Program, Transition Housing Program, CMP, HDH, and Vertical Housing Programs;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance;
