A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH VARSITY HILLS HOMEOWNERS ASSOCIATION FOR THE PROVISION OF ACCESS ROUTES FOR THE GENERAL PUBLIC.

WHEREAS, the Quezon City Government envisions to be a model of effective governance and responsible leadership, working in partnership with the citizenry in building a Quality Community and has a mission to provide quality service which will make Quezon City an ideal community where people live, work and do business in a hospitable, progressive and peaceful environment;

WHEREAS, the Varsity Hills Homeowners Association shall provide the general public free passage through the Access Route starting westwards from the intersection of Katipunan Avenue and B. Gonzales Street, then south to C. Salvador Street, then west to Rosa Alvero Street, then south to Jocson Street exiting to Xavierville Avenue, and vice versa during the Access Period from 5:00am until 9:00pm everyday, except for Sundays and all non-working holidays;

WHEREAS, the Quezon City Government shall allow the Varsity Hills Homeowners Association to keep and maintain its already existing guardhouses and other allied structures and to construct additional security structures along the Access Routes;

WHEREAS, the Quezon City Government may provide additional personnel to enforce traffic laws, rules, and regulations along the Access Routes during the Access Period;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with Varsity Hills Homeowners Association for the provision of access routes for the general public.

RESOLVED FURTHER, that a copy of the subject Memorandum of Agreement shall form an integral part of this Resolution
