A RESOLUTION CONDEMNING THE KILLING OF A STUDENT OF CARLOS L. ALBERT HIGH SCHOOL, DISTRICT IV, QUEZON CITY AND HEREBY URGING THE QUEZON CITY POLICE DISTRICT, SCHOOLS DIVISION OFFICE, BARANGAYS, GPTA AND THE EDUCATION AFFAIRS UNIT TO ADOPT A PROGRAM THAT WILL PREVENT THE RECURRENCE OF THE SAME CRIME WITHIN AND OUTSIDE THE VICINITY OF ALL PUBLIC SCHOOLS IN QUEZON CITY.

WHEREAS, the Quezon City Children's Code of 2012 recognizes the inherent rights of the child to survival, development, protection and participation;

WHEREAS, on September 15, 2022, at around 6:30 in the evening, an incident of stabbing happened infront of Puregold Supermarket, Araneta Avenue corner E. Rodriguez Senior, Barangay Doña Imelda, District IV, Quezon City;

WHEREAS, Sean Exekiel Millares Pastores, the victim, is a Grade 8 student of Carlos L. Albert High School and residing at No. 203 E. Rodriguez Sr., New Manila, Quezon City;

WHEREAS, based on the report, the victim was on his way home, when the suspects approached him with no apparent reason and mauled him wherein one of the suspects stabbed him twice hitting his chest and waist;

WHEREAS, the suspects are more or less ten (10) persons composed of males and females, some of them were in school uniform of Carlos Albert High School and some were not;

WHEREAS, the Local Government of Quezon City condemns this brutal and inhumane killing of the said student;

WHEREAS, the Quezon City Government is urging the Quezon City Police District, Schools Division Office, Barangays and the Education Affairs Unit to adopt a program that will prevent the recurrence of the same crime within and outside the vicinity of all public schools in Quezon City.
