BELMONTE, TO RENEW THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT AND THE THIRTY-ONE (31) ACCREDITED FUNERAL PARLORS IN QUEZON CITY FOR THE IMPLEMENTATION OF ORDINANCE NO. SP-2865, S-2019, OTHERWISE KNOWN AS "QUEZON CITY LIBRENG-PALIBING ORDINANCE OF 2019".

WHEREAS, on 9 October 2019, the City Government approved Quezon City Ordinance No. SP-2865, Series of 2019, otherwise known as the Quezon City Libreng-Palibing Ordinance of 2019, to provide a decent funeral services to qualified residents through guarantee letters in partnership with accredited funeral homes/service providers within Quezon City;

WHEREAS, on 16 March 2020, the Quezon City Council confirmed the Implementing Rules and Regulations of Quezon City Libreng-Palibing Ordinance of 2019;

WHEREAS, the Quezon City Council has previously adopted City Council Resolution Nos. SP-8241, S-2020 and SP-8490, S-2021 granting authority to the City Mayor to enter into a Memorandum of Agreement with the accredited funeral parlors in Quezon City for the implementation of Ordinance No. SP-2865, S-2019 otherwise known as "Quezon City Libreng-Palibing Ordinance of 2019";

WHEREAS, the thirty-one (31) accredited funeral parlors have pledged to extend their services in support of the City's Libreng-Palibing program for the qualified indigent residents of Quezon City, namely:

WHEREAS, the aforesaid funeral homes undertake that they are duly authorized to enter into a Memorandum of Agreement with the Quezon City Government. For this purpose, the Honorable City Mayor may enter into a MOA with any or all of the 31-Funeral Homes enumerated above, including subsequent renewal thereof;

WHEREAS, the decent funeral services standard cost shall not exceed Twenty-Five Thousand Pesos (Php25,000.00) in the form of guarantee letter per qualified beneficiary;

WHEREAS, the Social Services Development Department (SSDD) shall be responsible for the proper implementation of Quezon City Libreng-Palibing Ordinance of 2019 and its Implementing Rules and Regulations;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to renew the Memorandum of Agreement entered into by and between the Quezon City Government and the thirty-one (31) accredited funeral parlors in Quezon City for the implementation of Ordinance No. SP-2865, S-2019, otherwise known as "Quezon City Libreng-Palibing Ordinance of 2019".
