A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE COMMISSION ON HIGHER EDUCATION (CHED) UNDER THE INTERNATIONAL CONTINUING PROFESSIONAL EDUCATION (ICPE) GRANTS PROGRAM.

WHEREAS, the Commission on Higher Education (CHED) has approved the guidelines for International Continuing Professional Education (iCPE) program to support lifelong learning by providing short-term trainings to higher education faculty and staff provided by local and international institutions/organizations;

WHEREAS, the CHED, in partnership with the Asian Institute of Management (AIM), established the CHED-AIM Global Academic Leadership Program for Local Universities and Colleges (LUCs) Presidents and Government Partners (CHED-AIM GALP LUC) also referred to as the ICPE Program;

WHEREAS, the ICPE Program is a 10-week short training that generally aims to provide essential transformative leadership skills and to enable academic and support leaders to lead a globally competitive and locally responsive LUCs;

WHEREAS, through the Memorandum of Agreement, the CHED awards the City Government the ICPE grant for select grantees to complete short training with AIM;

WHEREAS, there is a need for the City Council to grant authority to the City Mayor before signing the Memorandum of Agreement for and in behalf of the Quezon City Government;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, represented by the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into and sign a Memorandum of Agreement with the Commission on Higher Education (CHED) under the International Continuing Professional Education (iCPE) Grants Program.
