WHEREAS, this is the first time the Philippines took home the WUDC title since its inception in 1981;

WHEREAS, winning the WUDC title brought pride and honor not only to the school, but more importantly to the Philippines and even the whole Asian continent, as we showed to the entire world that Filipino eloquence and critical thinking have always been world class.
