DAVID, MD MPH MPM CESO III, FOR THE DONATION OF THE TWO (2) MOBILE DENTAL CLINICS TO THE QUEZON CITY HEALTH DEPARTMENT.

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution provides, among others, that the State shall adopt an integrated and comprehensive approach to health development, which shall endeavor to make essential goods, health and social services available to all people at affordable cost;

WHEREAS, Section 22 of Republic Act No. 11223, otherwise known as the Universal Health Care Act, mandated the National Government to make available commensurate financial and non-financial matching grants, including capital outlay, human resources for health and health commodities, to improve the functionality of province-wide and city-wide health systems, provided that the grants shall be in accordance with the approved province-wide and city-wide health investment plans;

WHEREAS, the Health Facilities Enhancement Program (HFEP) aims to improve the delivery of health services through the upgrading of health facilities and provision of medical equipment in order to make them more responsive to the health needs of the population;

WHEREAS, oral disease continues to be a serious public health problem in the country and the main oral health problems are dental caries (tooth decay) and periodontal disease (gum disease) and these two oral diseases are so widespread wherein 87% of the people are suffering from tooth decay and 48% have gum diseases;

WHEREAS, the Quezon City is the partner of the DOH in implementing health programs and in delivering quality health services;

WHEREAS, the Department of Health would be donating to the Quezon City Health Department two (2) mobile dental clinics including equipment amounting to Four Million Nine Hundred Thousand Pesos (Php4,900,000.00) per unit with the following specifications:
