RESOLUTION NO. SP. 9.188, S-2023

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE TO BE USED BY THE OFFICE OF COUNCILOR SHAIRA "Shay" L.
