A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO SELL ONE (1) UNIT OF MOTOR VEHICLE ASSIGNED TO CARLOS VERZONILLA, OFFICER-IN-CHARGE, QCITIZENS SERVICES DEPARTMENT, THE PRICE OF WHICH IS TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO AUDITING AND ACCOUNTING RULES AND REGULATIONS.


WHEREAS, Mr. Carlos Verzonilla has expressed his intention to purchase his service vehicle because of its sentimental value;
