A RESOLUTION GRANTING THE RENEWAL OF THE SPECIAL PERMIT TO TOP WIN LUCKY GAMING CORP. FOR THE OPERATION OF A PAGCOR-LICENSED ELECTRONIC BINGO (E-BINGO) GAMES LOCATED AT NO. 29 UNANG HAKBANG STREET, BARANGAY SAN ISIDRO GALAS, DISTRICT IV, QUEZON CITY, SUBJECT TOTHE**RULES** ANDREGULATIONS PROMULGATED BYTHE**PHILIPPINE AMUSEMENT** AND GAMING CORPORATION (PAGCOR).

WHEREAS, Top Win Lucky Gaming Corp., a domestic corporation duly organized and existing under and by virtue of Philippine laws, is applying for the renewal of a Special Permit for the operation of a PAGCOR-Licensed Electronic Bingo (E-Bingo) Games located at No. 29 Unang Hakbang Street, Barangay San Isidro Galas, District IV, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the City Council for the operation of the same business through Resolution No. SP-8388, S-2020;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing City ordinances, authorizes the City Council to grant or renew a Special Permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the renewal of the Special Permit to Top Win Lucky Gaming Corp. for the operation of a PAGCOR-Licensed Electronic Bingo (E-Bingo) Games located at No. 29 Unang Hakbang Street, Barangay San Isidro Galas, District IV, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate Electronic Bingo (E-Bingo) Games granted herein shall be subject to the following conditions:

- a. Shall be required to pay a license fee annually equivalent to three percent (3%) of gross receipts in accordance with Section 25 of Ordinance No. SP-2773, S-2018, otherwise known as the Quezon City Gambling Regulatory Ordinance of 2018, and such other taxes and regulations promulgated by the Quezon City Government;
- b. Establishment shall not allow persons under twenty-one (21) years of age or students of any school, college or university to play in its gaming site;
- Establishment shall not be a nuisance to public safety and order;

- d. Establishment complies with all clearances, documentary requirements, and other applicable local ordinances and national laws.
