RESOLUTION NO. SP- 9213 , S-2023

A RESOLUTION RENEWING THE SPECIAL PERMIT OF BIG A GAMING CORPORATION TO OPERATE ELECTRONIC BINGO GAMES AND INSTAWIN AT NO. 218 BANAWE STREET CORNER QUEZON AVENUE, BARANGAY TATALON, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Big A Gaming Corporation is a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Arvin Tan, with business address at No. 218 Banawe Street corner Quezon Avenue, Barangay Tatalon, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-8159, S-2020;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to do business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Big A Gaming Corporation to operate Electronic Bingo Games and Instawin at No. 218 Banawe Street corner Quezon Avenue, Barangay Tatalon, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate Electronic Bingo Games and Instawin granted herein shall be subject to the following conditions:

- 1. The holding of Electronic Bingo Games and Instawin shall be in accordance with the rules and regulations promulgated by PAGCOR.
- 2. The operation of Electronic Bingo Games and Instawin shall not include playing of other games not related to Electronic Bingo.
- 3. The operation of Electronic Bingo Games and Instawin is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above-mentioned games.

RESOLVED FINALLY, that this renewal of Special Permit to operate an Electronic Bingo Games and Instawin shall be valid for a period of two (2) years from the approval of this Resolution and may be renewed again by the City Council.
