A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE EDUCATIONAL THEATER ASSOCIATION (PETA) FOR THE PRODUCTION OF "WALANG ARAY" AT THE PETA-PHINMA THEATER FROM FEBRUARY 17, 2023 TO MAY 14, 2023.

WHEREAS, on April 7, 1967, Cecile Guidote-Alvarez founded the Philippine Educational Theater Association (PETA) with the vision of a Philippine Theater engaged in the development of people and society;

WHEREAS, in 1971, PETA became the UNESCO-ITI (International Theater Institute) Center in the Philippines, and in the same year it organized the first Third World Theater Festival, held in the 400th year of the foundation of the City of Manila:

WHEREAS, the PETA Theater Center is a landmark in Philippine Arts and Culture, the Center itself is a testament to the creativity, ingenuity, resilience of PETA. The Center now serves as a physical base for the entire variety of PETA undertakings, from professional theater repertory performances, year-round workshops, and its community and outreach programs;

WHEREAS, PETA intends to hold a production of "Walang Aray" at the PETA-Phinma Theater from February 17, 2023 to May 14, 2023;

WHEREAS, the Quezon City Government intends to be an executive sponsor of forty (40) performances of "Walang Aray". In consideration thereof, the Quezon City Government shall extend financial assistance to PETA in the total amount of One Million Pesos (Php1,000,000.00);

WHEREAS, in return, PETA shall provide the logo inclusion, two hundred fifty (250) complimentary tickets for the play "Walang Aray", on-site promotions, and scholarship for ten (10) of the chosen scholars of the Quezon City Government in the upcoming PETA summer workshop.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Philippine Educational Theater Association (PETA) for the production of "Walang Aray" at the PETA-Phinma Theater from February 17, 2023 to May 14, 2023.

RESOLVED FURTHER, that a copy of the subject Memorandum of Agreement shall form as an integral part of this Resolution.
