A RESOLUTION RENEWING THE SPECIAL PERMIT OF BIGGAME, INC., TO OPERATE AN ELECTRONIC GAMES (E-GAMES) ESTABLISHMENT AT UNIT 105 TM PLAZA, TOMAS MORATO AVENUE CORNER ROCES AVENUE, BARANGAY SACRED HEART, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Biggame, Inc., is a domestic corporation duly organized and existing under and by virtue of Philippine laws, located at Unit 105 TM Plaza, Tomas Morato Avenue corner Roces Avenue, Barangay Sacred Heart, Quezon City;

WHEREAS, the applicant was previously granted Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-8432, S-2020;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit;

WHEREAS, the operation of Electronic Games (E-Games) is regulated and licensed by the Philippine Amusement and Gaming Corporation;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended by Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the City Council to grant or renew a Special Permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Biggame, Inc., to operate an Electronic Games (E-Games) establishment at Unit 105 TM Plaza, Tomas Morato Avenue corner Roces Avenue, Barangay Sacred Heart, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate E-Games granted herein shall be subject to the following conditions:

1. The holding of E-Games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
2. The operation of E-Games shall not include playing of other games not related to E-Games;
3. The operation is enjoined to prohibit individuals below eighteen (18) years of age or students of any school, college or university from playing in the abovementioned games in their gaming site;
4. Biggame, Inc., shall remit to the City Treasurer a license fee equivalent to three percent (3%) of its gross receipt, which shall be made payable yearly to the City Treasurer during the lifetime of this Resolution, in accordance with Section 25 of Ordinance No. SP-2779, S-2018, as amended; and
5. This Resolution is non-assignable, non-transferrable and site-address specific.
