A RESOLUTION RENEWING THE SPECIAL PERMIT OF TRIPLE 8 ENTERTAINMENT COMPANY, INC., FOR THE ESTABLISHMENT AND OPERATION OF ELECTRONIC BINGO AT PUREGOLD ARANETA CENTER, CUBAO, BARANGAY SOCORRO, DISTRICT III, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

*WHEREAS, Triple 8 Entertainment Company, Inc., a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Robert Yang and with business address at Puregold Araneta Center, Cubao, Barangay Socorro, District III, Quezon City, Metro Manila, is applying for a Special Permit to operate a Bingo Hall and Electronic Bingo Games;*

*WHEREAS, the applicant was previously granted Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-8340, S-2020;*

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended by Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the City Council to grant or renew a Special Permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Triple 8 Entertainment Company, Inc., for the establishment and operation of Electronic Bingo at Puregold Araneta Center, Cubao, Barangay Socorro, District III, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate Electronic Bingo Games granted herein shall be subject to the following conditions:

1. The holding of Electronic Bingo Games shall be in accordance with the Rules and Regulations promulgated by the PAGCOR;
2. The operation of Electronic Bingo Games shall not include playing of games not related to or other than Electronic Bingo Games;
3. The operation is enjoined to prohibit individuals below eighteen (18) years of age or students of any school, college or university from playing in the abovementioned games in their gaming site;
4. Triple 8 Entertainment Company, Inc., shall remit to the City Treasurer's Office a license fee equivalent to three percent (3%) of its gross receipt, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25 of Ordinance No. SP-2779, S-2018, as amended; and
5. This Resolution is non-assignable, non-transferrable and site address specific.
