A RESOLUTION DONATING ONE HUNDRED SIXTY-SEVEN (167) UNITS OF TENTS TO ALL THIRTY-SEVEN (37) BARANGAYS OF THE 1ST DISTRICT OF QUEZON CITY, AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAME TO THE RECIPIENTS WITHOUT COST


