WHEREAS, Total Gamezone Xtreme, Inc., is engaged in the business of Electronic Games;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-8427, S-2020;

WHEREAS, to enable the applicant to operate Electronic Games in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to Ordinance No. SP-2285, S-2014, in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the operation of Electronic Games and other approved Electronic Game Offerings is regulated and licensed by the Philippine Amusement and Gaming Corporation (PAGCOR);

WHEREAS, Total Gamezone Xtreme, Inc., is requesting the City Council to grant a Special Permit to operate Electronic Games and other approved Electronic Game Offerings.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Total Gamezone Xtreme, Inc., to operate Electronic Games and other approved Electronic Game Offerings at the 2<sup>nd</sup> Floor, MSK Building, No. 241 Visayas Avenue, Barangay Tandang Sora, District VI, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that Total Gamezone Xtreme, Inc., shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution.


