WHEREAS, it is the declared policy of the City to give priority to education with the vision of preparing the citizens to pursue their dreams, positively participate in society and compete in the global economy;

WHEREAS, Skaiwel Trading Solutions Inc., agrees to donate one hundred thirty (130) units of Canon Pixma G1010 printer, with a value of Eight Hundred Thirty-Five Thousand Three Hundred Eighty Pesos (Php835,380.00), to Quezon City public schools;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Deed of Donation with Skaiwel Trading Solutions Inc., for the donation of one hundred thirty (130) units of Canon Pixma G1010 printer to Quezon City Public Schools.

RESOLVED FURTHER, that a copy of the Deed of Donation be made an integral part of this Resolution.
