A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A DEED OF DONATION WITH VARIOUS LOCAL OR NATIONAL GOVERNMENT AGENCIES FOR THE DONATION OR TRANSFER, WITHOUT COST, OF THIRTY-NINE (39) CITY-OWNED MOTOR VEHICLES OF VARIOUS TYPES AND MODELS, AND TO TURNOVER DOCUMENTS PERTINENT TO ITS OWNERSHIP

WHEREAS, once donated or transferred to the end-user agencies, schools or barangays, a significant amount of funds can be saved by the City Government from the payment of said expenditures, as well as other incidental expenses incurred by these vehicles;

WHEREAS, in keeping with the thrust of the City to donate or transfer, without cost, the City-owned motor vehicles already assigned or issued or are not directly utilized by the City, a Deed of Donation shall be executed to formalize its conveyance to the intended recipient/s.
