A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, ON BEHALF OF THE QUEZON CITY GOVERNMENT, TO DONATE ONE HUNDRED SIXTY-FIVE (165) UNITS OF TENTS TO THIRTY-SEVEN (37) BARANGAYS IN DISTRICT I, QUEZON CITY AND TO TRANSFER THE OWNERSHIP TO ALL THE RECIPIENTS WITHOUT COST

WHEREAS, in order to shield the constituents of District I of Quezon City from wind, rain and intense heat of the sun and most especially in times of calamity caused by fortuitous events like storm or typhoon, the Local Government of Quezon City has purchased one hundred sixty-five (165) units of tents;

WHEREAS, the distribution of the said tents is necessary in the evacuation site to ensure the protection of the residents, especially in time of calamities or emergency cases;

WHEREAS, the turnover of said tents, through a Deed of Donation, shall be executed and ownership be turned over to the recipients without cost.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, on behalf of the Quezon City Government, to donate one hundred sixty-five (165) units of tents to thirty-seven (37) barangays in District I, Quezon City and to transfer the ownership to all the recipients without cost.
