A RESOLUTION GRANTING THE RENEWAL OF THE SPECIAL PERMIT OF EASY E-BINGO, INC., TO OPERATE AN ELECTRONIC BINGO GAMES ESTABLISHMENT AT EPS BUILDING, NO. 848 QUIRINO HIGHWAY, BARANGAY GULOD, NOVALICHES, DISTRICT V, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Easy E-Bingo, Inc., is a domestic corporation duly organized and existing under and by virtue of Philippine laws, located at EPS Building, No. 848 Quirino Highway, Barangay Gulod, Novaliches, District V, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-8406, S-2020;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew their Special Permit pursuant to an existing City ordinance;

WHEREAS, the operation of Electronic Bingo Games is regulated and licensed by PAGCOR;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit for business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the renewal of the Special Permit of Easy E-Bingo, Inc., to operate an Electronic Bingo Games establishment at EPS Building, No. 848 Quirino Highway, Barangay Gulod, Novaliches, District V, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an Electronic Bingo Games granted herein shall be subject to the following conditions:

- 1. The holding of Electronic Bingo Games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- 2. The operation of Electronic Bingo Games shall not include playing of games not related to or other than Electronic Bingo Games;
- 3. The operation is enjoined to prohibit individuals below twenty-one (21) years of age or any school, college or university student from playing in the abovementioned games in their gaming site;
- 4. Easy E-Bingo, Inc., shall remit annually to the City Treasurer a license fee of three percent (3%) of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this Resolution in accordance with Section 25 of Ordinance No. SP-2773, S-2018, as amended; and
- 5. That this Resolution is non-assignable, non-transferrable and site address specific.

RESOLVED FINALLY, that this renewal of Special Permit to operate an Electronic Bingo Games shall be valid for a period of two (2) years from the approval of this Resolution and may be renewed by the City Council.
