*WHEREAS, the Blackpool Dance Festival began in 1920 in the Empress Ballroom at the Winter Gardens in Blackpool, England;*

*WHEREAS, the Festival covers Ballroom and Latin American dancing, incorporating the British Open Championships for Adult Amateur and Professional couples, plus Formation Teams;*

*WHEREAS, the year 2019 was the event's 94<sup>th</sup> year and there were 56 countries represented, with a total number of 2,827 entries in the 13 events;*

*WHEREAS, Mr. Sergio T. Machon Jr. and Ms. Lina B. Machon successfully defeated all other participating countries and bagged home the championship trophy in the British Senior Latin Amateur (over 35's) category;*

*WHEREAS, due to the global pandemic, they were not able to defend their title in the years 2020, 2021 and 2022. Hence, this year, they will fly back to England to compete as defending champions.*


