*WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance;*

WHEREAS, the Quezon City Drug Treatment and Rehabilitation Center-TAHANAN (QCDTRC-TAHANAN) is the primary treatment rehabilitation of the Quezon City Government on its fight on drug abuse. It is also a dynamic and responsive client-centered drug treatment and rehabilitation facility with dedicated and caring professionals as change-agents geared towards healing and shaping maladaptive behaviors of drug dependents to be responsible and productive members of the community;

WHEREAS, the QCDTRC-TAHANAN, a stand-alone center that caters to drug abusers regardless of age, sex and ethnicity, will serve each Quezon City resident-patient with utmost care and will provide a menu of programs and services tailor-fitted to their specific needs using the Therapeutic Community approach;

WHEREAS, QCDTRC-TAHANAN is requesting for the purchase of one (1) unit motor vehicle with the following specifications:


