WHEREAS, *Barangay UP Campus is a local government unit within the Fourth Legislative District of Quezon City;*

WHEREAS, *Barangay UP Campus has a Health Care Program for its constituents, including the plan to make available an effective, affordable and accessible treatment for dialysis patients residing within its territorial jurisdiction, other Quezon City Barangays and other neighboring localities;*

WHEREAS, *Barangay UP Campus is the present occupant of a building located at Amorsolo Civic Complex, Barangay UP Campus, District IV, Quezon City which is owned by the Quezon City Government and is used and/or devoted for the provision of public services;*

WHEREAS, *Barangay UP Campus desires and requests that a portion of the said property, with a total floor area of one hundred twenty (120) square meters, be repurposed from its current use for the possible establishment of a dialysis center, which may be in cooperation with third parties, and for the benefit of its constituents;*

WHEREAS, *pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.*

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with Barangay UP Campus, represented by its Punong Barangay, Honorable Zenaida P. Lectura, for the repurposing of a portion of a building owned by the Quezon City Government with a total area of one hundred twenty (120) square meters located at Amorsolo Civic Complex, Barangay UP Campus, District IV, Quezon City.
