A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO EXECUTE AND SIGN THE DEED OF DONATION AND ACCEPTANCE FOR THE DONATION OF 5 UNITS OF PATIENT TRANSPORT VEHICLES TO THE BARANGAYS IN THE 2ND DISTRICT OF QUEZON CITY

WHEREAS, the Office of the Honorable Ralph Tulfo has facilitated the release to the Quezon City Government, through the Office of the City Mayor, an amount of Php12,500,000.00 through the Local Government Support Fund – Financial Assistance to Local Government Units and Support for Capital Outlays and Social Programs under the Fiscal Year (FY) 2023 General Appropriations Act for the purchase of 5 units of Patient Transport Vehicles;

WHEREAS, the Bureau of Treasury has issued a Notice of Authority to Debit Account in the amount Php12,500,000.00 to cover the purchase of 5 units of Patient Transport Vehicles;

WHEREAS, as per Purchase Order No. 2406098, the unit cost of the Patient Transport Vehicle is Php2,410,000.00;

WHEREAS, the abovementioned Patient Transport Vehicles shall be donated to the 5 barangays in the 2nd District, Quezon City to be utilized for medical, rescue and emergency purposes, to wit:
