A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A DEED OF DONATION AND ACCEPTANCE WITH VARIOUS BENEFICIARIES FROM THE DIFFERENT BARANGAYS OF THE 4<sup>TH</sup> DISTRICT OF QUEZON CITY FOR THE DONATION OF 20 UNITS OF TENTS AND AUTHORIZING THE TRANSFER OF OWNERSHIP THEREOF TO ALL RECIPIENTS WITHOUT COST

WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, the 20 units of tents to be donated herein will be used for meetings and activities of different organizations in their respective barangays;

WHEREAS, said 20 units of tents will be distributed to qualified beneficiaries from different barangays and organizations in the 4<sup>th</sup> District of Quezon City;

WHEREAS, the following are the specifications of the tents to be donated and distributed: steel frame, canvass, 11 feet x 11 feet;

WHEREAS, the donation of 20 units of tents aims to improve the delivery of administrative services in the 4<sup>th</sup> District of Quezon City;

WHEREAS, for the effective transfer of ownership to the recipients of the said 20 units of tents, the City, as Donor, shall assume all fees and cost of the donation.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Deed of Donation and Acceptance with various beneficiaries from the different barangays of the 4<sup>th</sup> District of Quezon City for the donation of 20 units of tents and authorizing the transfer of ownership thereof to all recipients without cost.
