A RESOLUTION AMENDING QUEZON CITY RESOLUTION NO. SP-9683, S-2024 ENTITLED "A RESOLUTION RENEWING THE SPECIAL PERMIT OF B-7 AMUSEMENT CORPORATION TO OPERATE A TRADITIONAL AND ELECTRONIC BINGO GAMES ESTABLISHMENT AT EVER GOTESCO, COMMONWEALTH AVENUE, BARANGAY BATASAN HILLS, DISTRICT II, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT GAMING CORPORATION (PAGCOR)" TO AMEND THE NAME OF ITS OPERATOR

*WHEREAS, B-7 Amusement Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws and now operated by Triple 8 Amusement and Development Corporation, is applying for the amendment of its Special Permit to operate a Traditional and Electronic Bingo Games Establishment at Ever Gotesco, Commonwealth Avenue, Barangay Batasan Hills, District II, Quezon City;*

*WHEREAS, Quezon City Resolution No. SP-9683, S-2024 was adopted by the City Council last June 3, 2024 and the same is effective for 3 years or until 2027; however, the said Resolution erroneously indicates that B-7 Amusement Corporation is operated under the name of RAC Phil Corp. instead of Triple 8 Amusement and Development Corporation;*


WHEREAS, On May 28, 2024, B-7 Amusement Corporation and Triple 8 Amusement and Development Corporation entered into a Memorandum of Agreement for the transfer of operation of Traditional and Electronic Bingo Games Establishment in favor of the latter.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend Quezon City Resolution No. SP-9683, S-2024 entitled "A Resolution renewing the Special Permit of B-7 Amusement Corporation to operate a Traditional and Electronic Bingo Games Establishment at Ever Gotesco, Commonwealth Avenue, Barangay Batasan Hills, District II, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement Gaming Corporation (PAGCOR)" to amend the name of its operator.

RESOLVED FURTHER, that the Special Permit granted to B-7 Amusement Corporation through Quezon City Resolution No. SP-9683, S-2024 is now transferred to and owned by Triple 8 Amusement and Development Corporation.
