A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MIKA CRIZEL U. UY FOR THE CONSTRUCTION AND OPERATION OF A PROPOSED 3-STOREY MIXED-USE BUILDING (COMMERCIAL-GROUND FLOOR AND INDUSTRIAL WAREHOUSE – 2<sup>ND</sup> AND 3<sup>RD</sup> FLOORS) WITH ROOF DECK, COVERING A TOTAL FLOOR AREA OF 4,992.82 SQM. LOCATED AT LOTS 48, 49 AND 50, SUSANO ROAD CORNER BETHZAIDA STREET, BARANGAY SAN AGUSTIN, DISTRICT V, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. WHEREAS, Mika Crizel U. Sy is applying for the issuance of a Certificate of Exception for the construction and operation of the Proposed 3-Storey Mixed-Use Building (Commercial-Ground Floor and Industrial Warehouse – 2<sup>nd</sup> and 3<sup>rd</sup> Floors) with Roof Deck, covering a total floor area of 4,992.82 square meters located at Lots 48, 49 and 50, Susano Road corner Bethzaida Street, Barangay San Agustin, District V, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2016;

WHEREAS, the Sangguniang Barangay concerned and the residents nearby the place of business interpose no objection to the operation of the said business establishment;

WHEREAS, the Proposed Construction and Operation will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community, and will provide employment and promote economic development in the City;

WHEREAS, pursuant to Paragraph 2, Section 55, Article VIII of Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2016, a Certificate of Exception shall be required for the aforementioned Proposed Construction and Operation subject to the authorization of the City Council through a Resolution;

WHEREAS, the Proposed Construction and Operation has complied with the necessary requirements for the issuance of a Certificate of Exception as mandated by the Quezon City Comprehensive Zoning Ordinance of 2016.











NOW, THEREFORE,
